Workshop, Rapid Fire & Poster Submission Guidance

Submissions that most closely align with the 2025 NNN Conference theme: **"Sustainable Innovations for Impact – Transforming the Fight Against NTDs"** and the strategic objectives of the NNN will have the strongest chance of selection. The theme merges sustainability, innovation, and impact, ensuring that technological advancements and new strategies lead to long-term success in eliminating NTDs. The focus on sustainable programming aligns with the WHO NTD road map overarching objectives.

Please make sure to read through the notes below before submitting your proposal. A selection committee will review the proposals that are received no later than **Sunday 20th April 2025 23:00 ET.**

Submission Types

This year we are delighted to offer our members the opportunity to submit proposals for:

- **Workshop Sessions:** The NNN workshops take a 90-minute format, which includes key presentation(s) on the session topic and focuses on breakout activities and meaningful discussions. Workshops are typically organised in three parallel sessions over the course of the three-day conference.
- **Rapid Fire presentations:** These 8 minute presentations are specifically designed for presenting completed work with evidence of success and learnings. The format aims to focus on the exciting core findings and practical implications of research, supported by a limited number of slides and followed by a brief Q&A with the audience.
- **Poster presentations:** We are accepting a limited number of In-Person Poster presentations, to take place on one day of the conference, that cater to the larger NNN theme and sub-themes from early career professionals and full-time students registered on programmes in LMICs.



Conference Sub-Themes

The Conference Committee has carefully curated a programme and considered sub-themes that are of interest to the NNN community and is inviting submissions in the following sub-themes. Please note whilst we have offered several examples for each sub-theme, these are not restrictive and are only for guidance, we encourage you to be creative and explore different topics and ideas:

Review & Selection Criteria

Each submission will receive 3 blind reviews from volunteer reviewers from the NNN community who have expressed expertise and experience in the conference sub-themes. The NNN Submission Reviewers will carefully consider proposals using the following criteria, scoring each on a scale of 1 (Poor) through to 5 (Outstanding).

Each criteria is equally weighted and the submissions with the highest average scores will be shortlisted for review by the NNN Steering Committee to ensure alignment with and balance across conference sub-themes. (Please see detailed Criteria Descriptions below):

The NNN Steering Committee will complete the review process by carefully considering the NNN Reviewers' scores and feedback, thoroughly reviewing the shortlists to curate a programme that balances sub-themes, geographical regions, diversity, organisational presence and new voices.

Selection Criteria Descriptions

All submissions will be selected using the following criteria, please note workshops will be scored on all 5 criteria:

1. **Relevance to NTD programme design & delivery:** all submissions should provide learning relevant to multiple NTD programmes or share best practice / evidence of cross sectoral collaboration of NTDs with other areas of health. Disease specific submissions should be framed explicitly to enable lessons to be applied to broader NTD programmes or cross sector collaborations.
2. **Clear objectives:** the submission should include clear learnings / learning objectives. All workshop submissions should demonstrate how the structure will achieve those learning objectives.
3. **Quality of proposal:** the submission should demonstrate a clear flow, starting with the background on the issue/s to be discussed, rationale for conducting a workshop / making a presentation (including how the workshop / presentation will build on previous discussions), and in the case of workshops, explanation on how the workshop conclusions will be followed up by the organisers.
4. **Innovation:** the proposal should present or share ideas that can be replicated, highlight new learnings, tools, knowledge, showcase best practices and bring forward innovation to the conference.
5. **Interaction & participation (for workshops only):** the workshop should be structured to encourage a broad range of audience participation. Workshops containing only presentations or panels with no audience interaction are less likely to be accepted.

- As workshop sessions are limited to 12, we ask for the workshop lead to please confirm and accept via email by **FRIDAY 6th June**.
- Workshop lead/s should attend the Workshop Lead Orientation session on **THURSDAY 12th June at 13h BST** (please add this date to your calendar).
- Once successful applicants have been notified, the workshop lead/s will be sent a Google document to complete for both their Workshop Logistics and Workshop Agenda. Please complete by **FRIDAY 11th July** so that the information can be uploaded into the system.
- A final deadline for checking the online platform, finalising speakers and making final amendments to the workshop outline is **FRIDAY 5th September**.
- Please also share all presentations and video content by this date.

Rapid Fires & Posters:

- Successful Rapid Fires & Posters will be notified by email on **FRIDAY 30th May**.
- The Rapid Fire & Poster presenter name, submission title and short description must be shared by **FRIDAY 11th July** so we can create the timetable and promote the sessions.
- A final deadline for checking the online platform, finalising speakers and making final amendments to the presentation outline is **FRIDAY 5th September**.

Step by Step Workshop Submission Guidance

Workshop Planning Recommendations

- **The purpose of the NNN Conference is to amplify the role of the network as a community of practice. Therefore:**
- **Collaborative submissions through NNN Working Groups** are strongly encouraged as this is an excellent way of ensuring multiple organisations and perspectives feed into the workshop shaping & design. Before making a submission for a workshop, we encourage potential submitters to reach out to relevant disease specific or cross cutting working groups to explore the possibility of a joint submission.
- **We often receive multiple submissions on similar topics.** We will favour joint submissions where organisations come together to collaborate and co-facilitate the session.
- **Diversity of speakers / facilitators / panellists:** the workshop should involve a range of participants across multiple organisations with an emphasis on engagement and participation of speakers from NTD endemic countries; across genders; and persons affected by NTDs.
- **The workshop facilitator and at least one speaker must attend the conference in-person** in Kampala so that the workshop can sufficiently engage in-person attendees. Any speakers who are unable to attend must pre-record their presentation as a video; however, this should be used only if key speakers are unable to attend. Workshop leads should avoid having multiple pre-recorded presentations as this affects workshop quality and participation.
- Consider the planning of your agenda **allowing time for meaningful discussion during breakout activities**, and establish how you will engage both in-person and virtual attendees. (Technical support for virtual breakout rooms for online attendees will not be provided by the conference organisers but can be set up by the workshop leads).
- Whilst there is no limit to the number of workshops you can propose, during the submission process we will ask you to prioritise your submissions in order to maximise the number of individuals and organisations able to host a workshop. **We would strongly recommend that each organisation coordinates the number of workshop submissions made on its behalf**, focusing on submitting fewer, high quality proposals.



- **All participants in your workshop, including any speakers, moderators, and rapporteurs must register for the event** in order to have access to the NNN Conference rooms and therefore participate in the workshop. This applies to both virtual and in-person participants.
- **The submission for the workshop must be written in English.** While the NNN are unable to cover the interpretation services for workshops, MYT, the professional conference organiser (PCO) can recommend Interpretation Suppliers for you to obtain quotations.

Publication

Rapid fires & digital posters will be published electronically on the 2025 NNN Conference platform. No printed abstract book will be produced. Submissions will be reviewed for their structure, content, perceived value to 2025 NNN Conference delegates and degree of innovation. All decisions are final.

Registration and Travel Costs

All confirmed presenters will be required to register for the 2025 NNN Conference no later than **17th August 2025**. According to the policy of the 2025 NNN Conference, all participants in the programme will be responsible for their own registration fees, hotel, visas, and travel expenses. Since all participants, including those in leadership positions are covering their own expenses, we regret that we cannot waive registration fees or cover expenses for any participant in the programme, including Convenors, Chairs, Speakers, or Participants.
